Proposal: Election of Eight (8) Directors (excluding Directors who are Audit and Supervisory Committee Members)

The maximum amount of liability under said agreement is the maximum liability amount as provided under the relevant laws and regulations. If the reelection of Jun Otomo, Kenji Shimizu, Hiroyuki Fukuda and Kiyoshi Nagai is approved, the Company intends to continue said agreement.
- 9. The Company has entered into an officers, etc. liability insurance contract stipulated in Article 430-3, Paragraph 1 of the Companies Act with an insurance company, whereby the insured shall be compensated for losses related to legal damages and legal costs, etc. for which they are responsible.
 In the event that the election of the candidates is approved, they shall each be included in the insured under this contract. When this contract is next renewed, the Company intends to extend it on the same terms and conditions.

In the event that the reelection of the candidates is approved, the Company continuously intends to register them as Independent Officers stipulated by the Tokyo Stock Exchange.
